LLOYD K. GARRISON LECTURE ON ENVIRONMENTAL LAW

The Lloyd K. Garrison Lecture at Pace University School of Law celebrates the vision, public spirit, and life of Lloyd K. Garrison, an attorney who over forty years ago, along with his associate, Albert K. Butzel, of Paul, Weiss, Rifkind, Wharton & Garrison, helped usher in the field of environmental law by winning the landmark case of *Scenic Hudson Preservation Conference v. Federal Power Commission*, 354 F.2d 608 (2d Cir. 1965) cert. denied, 384 U.S. 941 (1966) to preserve Storm King Mountain on the Hudson River. Lloyd K. Garrison was a graduate of Harvard College and School of Law. During his long and illustrious career he helped start the National Labor Relations Board, served as Dean of the University of Wisconsin Law School, marked his role with the Association of the Bar of the City of New York and participated in numerous federal commissions and agency activities for such Presidents as Herbert Hoover, Franklin D. Roosevelt and Harry S. Truman. A great-grandson of William Lloyd Garrison, he was also a member of the National Urban League and labored constantly in support of civil rights, defending Arthur Miller, Langston Hughes and J. Robert Oppenheimer during the McCarthy Era. Lloyd K. Garrison passed away in 1991 at the age of ninety-three. This Lecture was established in his honor and memory in 1995, four years after his death.
